
Federated catalog with full circulation functionality will allow:

Nuanced analysis using patron statistical categories


Collection development practices to support the unique strengths of universities, including shared storage

Alignment of collections across the curriculum at all participating universities, with the ability to loan collection subsets across libraries



**OLE Modules** 









**Patron record** preferences allows library users to specify their best means of contact. **Item Records/Fast Adds.** If an item does not have a barcode, library staff may quickly create a brief bibliographic record and check out the item.

**Circulation Desks** are the work areas that provide services for items in designated shelving locations. Operators are authorized to work at designated Circulation Desks. **Loan/Renewal** of library OLE leverages Kuali Rules Management System (KRMS), a flexible and extendable business rules management tool, as a framework for the circulation policies (e.g., determining loan periods).

**Return** of circulated resources

Requests – hold for pickup or deliver

**Notices and Other Batch Processes** include due date reminders, expired hold and hold notices, replacement fees and overdue fines as well as changing item status from "recently returned" to "available"

"My Account" Features for Patrons to view their library materials and perform some circulation functions

Billing for lost items, overdue fines and other charges.




## **OLE's Design Flexibility is Key**

OLE creates rules, that are XML statements about:

- Patrons
- Locations
- Item types
- Other conditions (number of books checked out, blocks, etc.)

Three or Four-character prefix for patrons, items is key: NJIT\_FacStf RUL\_Guest



OLE rules are XML arguments of conditions that are true or false

These are grouped into a workflow or scenario of use, known as an Agenda

The same rules engine is used for everything, not just circulation.

This makes it easy to integrate staffing rules with circulation rules to ensure local stewardship of patrons and collections


