# **VALE Executive Committee Meeting**

# 4) Purchasing & Licensing Report (Keller / Wagner)

- Wagner commended Richard Kearney for his participation and leadership in P&L.
- Had P&L meeting with full committee in August. Discussed the WALDO dissolution and transition to Lyrasis. Awaiting information on VALE-Lyrasis membership fee.
- Discussed VALE & NJEdge relationship. They will discuss revision of MOU.
- A small group will discuss the VALE-WALDO license agreements. Lyrasis will require a new agreement between VALE and Lyrasis for WALDO subscriptions.
- The VALE-Kanopy agreement is still being discussed.
- Considering investigating Library Lever as a vendor.
- ACRL-NJ / NJLA-CUS has created an Electronic Resources Committee that is focused on professional development.

# 5) OER Report (Hilliker / Mizzy)

- Ambassadors would like to launch an application process ASAP to run another course in January.
- VALE's strategic agenda for the OER initiative will guide the work of the OER Committee.
- A discussion ensued about the VALE Executive Committee's responsibility in creating an OER strategic agenda.
- Mizzy asked the group to consider what would success look like for VALE and what objectives is VALE looking to achieve.

- Five Working groups were identified, and charges for each were created: collections, advocacy & outreach, programming, governance and policies, and staff development.
- Includes libraries from all sectors.

### 15) VALE Program Manager (Hoang/Ochoa)

  national search for a permanent or to hire him in the permanent role. The group
  agreed to appoint Joe as interim for now and review the next steps later.
